# HEALTH AND SAFETY

### **HUMAN RIGHTS**

Suppliers of Eimskip commit themself to comply with all applicable laws and regulations on human rights concerning freedom of association, forced and compulsory labor, child labor and discrimination in respect of employment and occupation. Eimskip embraces diversity and inclusion and ask suppliers to enthusiastically support those efforts.





### LABOR

Suppliers are expected to comply with international laws and regulations on the minimum age of employees. Employees of suppliers have the right to join or not to join a labor union. Also, the right to reject and act against all forms of forced and compulsory labor.

Pay their employees no less than the minimum wage as required by law and/or wage agreements in the country of occupation. Adhere to all laws and regulations on the rights of employees e.g., for rest, length of working hours, holidays, sick leave, and other benefits. Suppliers further reject any kind of discrimination regarding employment, occupation, and human rights. Eimskip is committed to comply with all applicable laws and regulations governing the professional activities and expect the same of their suppliers. As well as compliance to general standards of business ethics and corporate governance.



### **BUSINESS ETHICS**

All relevant and applicable laws and regulations supplemented with rules and general standards of business ethics apply to suppliers. Any conflict of interest should be avoided in business transactions with Eimskip. Any possible match should be reported, including the risk of corruption and bribery. Suppliers avoid making decisions that lead to conflicts of interest of any kind. Adhere to antitrust and other competition laws. Eimskip conducts its actions against money laundering and terrorist financing in accordance with best practices for financial undertakings.



## GIFTS AND ENTERTAINMENT

Reasonable and appropriate gifts and entertainment are allowed, given, or received for normal and legitimate business purposes. Gifts and entertainment of higher value than €75 should be pre-approved. Cash or cash equivalents may not be given or received.
